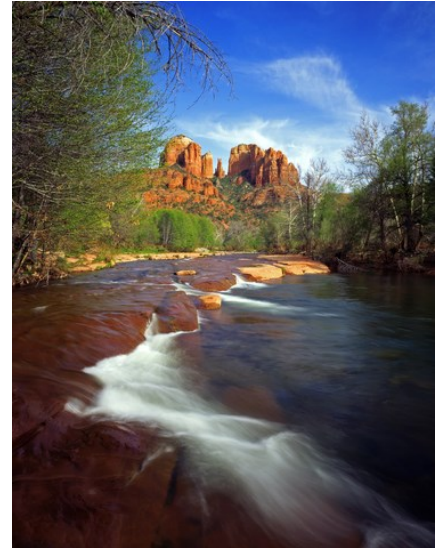
Day 1 May 21, Sunday
